- Full-bleed ad backgrounds (or images) must have a bleed allowance at least 1/8" beyond the trim size on all sides.
- Please offset cropmarks 1/8" (.125") in the "Marks and Bleeds: Offset" setting when creating your PDF file, so that crop marks are not visible on the printed page.
